## ROAD TO A MILLION – OFFICIAL RULES

The Road to a Million Promotion is intended for the 50 United States and D.C. only and will be constructed and evaluated according to United States laws. 1. How to Enter: Beginning at 6:00 p.m. Central Time ("CT") on March 23, 2023 (the "Commencement") until the date and time where Uncle Nearest, Inc. ("Sponsor") receives its one millionth visitor or until 11:59 p.m. on December 31, 2026 (the "End"), you may enter the Road to A Million (the "Promotion") by visiting the Nearest Green Distillery located at 3125 US-231, Shelbyville, Tennessee 37160, and completing and submitting the entry form that will be available by scanning the Road to a Million QR codes (an "Entry"). The Commencement to the End shall be the "Promotion Period."

Road to a Million QR Codes will be posted on signage at locations at the Nearest Green Distillery, 3125 US-23, Shelbyville, TN 37160, including the Welcome Desk and Checkout Counters at the Welcome Center, in Barrel House II by the registers, and near the bar in Humble Baron.

Each visitor ("You" or "Your") that participates in the Promotion must provide Your full name, date of birth, email address, and zip code in Your Entry. All Entries must be received by the end time and date of the Promotion Period to be eligible for the drawing. Incorrect and incomplete Entries are void.

Note: In order to register, ad blocking software on Your computer or device may need to be disabled. The Sponsor does not warrant that QR Codes will function on Your computer or device or that Your computer or device will complete an Entry.

Limit of one (1) Entry per eligible person per calendar week during the Promotion Period. Limit of twelve (12) Entries per eligible person per calendar year during the Promotion Period. If more than 1 Entry is received during the same calendar week, only the first Entry will be accepted and additional Entries will be disqualified. If more than 12 Entries are received during the same calendar year, only the first 12 Entries will be accepted and additional Entries will be disqualified. Multiple participants are not permitted to share the same email address. The birthdate You provide in Your Entry will verify your eligibility under this requirement. - 3. Privacy: In connection with the Promotion entry process, Sponsor may be collecting personal data about You in the entry form in accordance with Sponsor's privacy policy. By participating in the Promotion, You hereby agree to Sponsor's collection and usage of Your personal information and acknowledge that You have read and accepted Sponsor's privacy policy. When you submit an Entry, You may be asked to consent to receive promotional emails and reminders for upcoming promotions and information about Sponsor. Consenting to receive such emails is optional and does not have to be agreed to in order to be eligible to enter the Promotion and does not improve Your chances of winning.

Online submission is not considered proof of delivery or receipt. Upon submission, all Entries become the property of Sponsor and will not be returned. Sponsor reserves the right to conduct a background check on any prospective Grand Prize Winners (as defined below) and reserves the right in its sole discretion to disqualify any person based on such background check if Sponsor determines in its sole discretion that awarding the prize to such prospective Grand Prize Winner might reflect negatively on Sponsor. The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.

<u>6. How Winner will be Determined</u>: Ten (10) prospective Grand Prize Winners (the "Grand Prize Winners") will be selected in a random drawing from among all eligible Entries received during the Promotion Period. Sponsor will use commercially reasonable efforts to contact Grand Prize Winners by phone or email on within five (5) business days following the

drawing. Sponsor's decisions with respect to the prospective Grand Prize Winners, these Official Rules, and all other matters pertaining to the Promotion shall be final and binding. Any action or litigation concerning this Agreement shall take place exclusively in the state courts sitting in Bedford County, Tennessee, and You expressly consent to the jurisdiction of and venue in such courts and waive all defenses of lack of jurisdiction and inconvenient forum with respect to the courts. Any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, shall be resolved individually, without resort to any form of class action. You agree to service of process by mail or other method acceptable under the laws of the State of Tennessee. Severability: If any provision of these Official Rules shall be held invalid, illegal, or unenforceable, such provision shall be enforced to the maximum extent permitted by law and the Sponsor's fundamental intentions hereunder, and the remaining provisions shall not be affected or impaired, provided, however, that in such cases the parties oblige themselves to use their best efforts to achieve the purpose of the invalid provision by a new legally valid stipulation.
